# THE TURKISH NATION HAS BEEN SENTENCED! WE DO NOT RECOGNIZE YOUR JUDGMENT!

# The Turkish Nation has been sentenced

Not only patriots were sentenced in the Ergenekon Plot. The Turkish Nation, the Republic of Ataturk, the Turkish Revolution, patriotism and the Turkish Army has been sentenced with this judgment.

# The US-guided AKP fascism

The judgment is the peak and latest example of the AKP fascism.

The US Gladio decided and the F type personnel announced it. (F type: Fethullah Gulen movement; an US led "moderate Islam" movement)

As we stated from the very beginning, the aim of the "judgment show" in Silivri was to crash down the Turkish Army and the Workers' Party (Turkey).

# We do not recognize the judgment

This "trial show" is entirely unlawful.

The announced judgment is illegal and illegitimate.

We do not recognize it!

The judgments will last as long as Erdogan and Guls co-presidency of the Greater Middle Eastern Project (GMEP) lasts.

The Chairman of Workers' Party, Dogu Perincek, was sentenced to aggravated life sentence and 117 years additionally. Following is his first article written on the night of the judgment on the 5th and published in the daily newspaper Aydinlik, on the 6th of August.

When the Ilker Yucels (Chief Editor of Aydinlik) and Cagdas Cengizes (Chairman of the Turkish Youth Union TGB) were detained, I was so enthusiastic that I hugged my friends. It is greatly reassuring to have such a youth. In his TV programme on Ulusal Kanal (National Channel) Soner Yalcın began his words by saying "I am very enthusiastic". The same feelings.

Afterwards, we saw the fear of the government and the illegitimate judgments of the special assigned institutions.

These could not overshadow our enthusiasm. Because what we have been desiring since 50 years, what we have been working for since 50 years, is now becoming reality.

The Turkish Nation stood up for a revolution for the first time since the 1920'ies.

Our Party is the staff and the vanguard of the great up rise of our nation.

A young generation, unique across the world, has intervened on the future of Turkey in organized manner.

We dedicated our lives for those days. We see that our aspirations are very close, now.

We are very enthusiastic.

We are very happy.

I had told you yesterday that there is no court of law behind that wire fence.
